#### *Trust Protectors For Your Pet*

Perhaps you have set up a trust for the care of your pet should your pet outlive you. But how can you be sure the terms of the trust will be carried out? Connecticut recently passed a law to permit the creation of pet trusts, thereby helping you to ensure your pets will not be neglected or euthanized if they outlive you.

The new law requires the trust to designate a trust protector who acts on behalf of the animal to assure that the trust is carried out appropriately. A Superior Court or probate court would have jurisdiction over your pet, only to be terminated upon the death of your pet.
